The Melamchi Municipality, Office of the Municipal Executive invites *electronic* bids from eligible Authorized bidders for the procurement of "*Procurement of Pipes & Fitting Materials for Phatakshila Water Supply Project*" *under National competitive bidding procedures specified in Public Procurement Act and Regulations.*

- 3. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents at Melamchi Municipality, Office of the Municipality, Melamchi Sindhupalchok or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document NRr 3,000.00 in the following Rajaswa (revenue) account as specified below .

- 4. Pre-bid meeting shall not be held.
- 5. Electronic bids must be submitted to the office through PPMO's e-GP system <u>www.bolpatra.gov.np/egp</u> on or before 2076/1/18, 12:00. Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2076/1/18, 13:00 at the office of Melamchi Municipality, Office of the Municipality, Melamchi Sindhupalchok. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 1,75,000.00 which shall be valid for 30 days beyond the validity period of the bid.
- If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No: 1680300000003000004 (Ga-3) at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount along with the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 9. Bidders are advised to visit the site and assess the actual site conditions prior to submit the bid in their own cost.
- 10. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
- 11. If there are any changes or correction in notice or on bid document, the notice will be published in Melamchi Municipality notice board & web page.
- 12. Bidder may get details of e-bid procedure from Public Procurement Monitoring Office (PPMO) at Tahachal, Kathmandu Nepal.
- 13. Other things not included in bidding documents will be as per PPA, 2063 and PPR, 2064.
