- 1. **The Government of Nepal (GoN)** has allocated TB-SWAp funds to Melamchi Municipality for **Trail Bridge Program** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply of fabricated steel parts for Trail Bridges. Sealed Quotation is open to all eligible Nepalese Bidders.
- 2. The Melamchi Municipality invites sealed quotations from registered fabricators for supply of fabricated steel parts for following Trail Bridges. Detailed Evaluation and Qualification Criteria are provided in Section III of the Sealed Quotation Documents.
- 3. The Bidders/Fabricators with experience of successfully completing fabrication and supply of steel parts for minimum five trail bridges within last five years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted in nepaltrailbridges.org.np may also apply. However, sealed Quotations of such fabricators shall be considered responsive only in case fabricators fulfill the requirements.
- 4. Eligible Bidders may obtain further information and inspect the sealed Quotation documents at the office of Melamchi Municipality.
- 5. Sealed quotation documents may be purchased from the office of Melamchi Municipality, Melamchi, Sindhupalchok by eligible Bidders, on submission of a written application and upon payment of a non-refundable fee for sealed Quotation documents as NRs 1000.00, until 2076/09/28 from the first date of publication of this notice.
- 6. Sealed Quotations must be submitted at the office of the Municipal Executive, Melamchi, Sindhupalchok before **12:00 noon** on **2076/09/29**. Documents received after this deadline shall not be accepted.
- 7. Sealed Quotations will be opened in the presence of Bidders' representatives who choose to attend at Melamchi Municipality, Melamchi Sindhupalchok on 13:00 on 2076/09/29. Sealed quotation must be valid for a period of 45 days after sealed quotation opening and must be accompanied by bid security, amounting to a NRs 38500.which shall be valid for 30 days beyond the sealed Quotation validity period or If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in Deposit Account No.1680300000004003001 of melamchi municipality at Nepal Bank Ltd, melamchi Branch, sindhupalchok and submit bank deposit voucher along with the sealed Quotation.
- 9. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered as the last day.
- 10.. Pre-Sealed Quotation meeting shall not be held.
