- Sealed quotation/ bids must be submitted to the Melamchi Municipality office by hand on or before as specified above Bids received
 after this deadline will be rejected.
- 5. The quotation /bids will be opened in the presence of Bidders' representatives who choose to attend at as specified above at the *Melamchi Municipality office*. Bids must be valid for a period of 45 days for BID MMSI/GOODS/2075-76/03 and 90 days for BID MMSI/GOODS/2075-76/04 after bid opening and must be accompanied by a bid security. which shall be valid for 30 days beyond the validity period of the bid
- 6. If bidder wishes to submit the Bid Security in the form of cash, the cash should be deposited in Deposit Account No: 1680300000003000004 (Ga-3) at Nepal Bank Limited, Melamchi, Sindhupalchok and submit the receipt of the deposited amount of cash along with the bid.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
- If there are any changes or correction in notice or on bid document, the notice will be published in Melamchi Municipality notice
- 10. Bid will open at Melamchi Municipality Office, Melamchi Sindhupalchok, Nepal.
- 11. Those owners whose firm or company was blacklisted earlier with the provisions of Public Procurement Act, 2007 and if they have commenced New Business in the name of new firm or company are not allowed to participate in the Bid Proceedings.
