4. Pre-bid meeting shall be held at Melamchi Municipality, Office of the Municipal Executive, Melamchi Sindhupalchok on 2076/11/21 at 12:00 Hrs.
5. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp as mentioned above. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at the Melamchi Municipality, Office of the Municipal Executive, and Melamchi Sindhupalchok as stated above. Bids must be valid for a period of **90 days after** bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **as mentioned above**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
