- 1. **The Government of Nepal (GoN)** has allocated funds to Melamchi Municipality for **Ayurvedic Medicine** and the Municipality intends to apply the funds to cover eligible payments under the Contract for supply and deliver of medicine. Sealed Quotation is open to all eligible Nepalese suppliers.
- 2. The Melamchi Municipality invites sealed quotations from registered Ayurvedic suppliers for supply of Ayurvedic medicines. Detailed Evaluation and Qualification Criteria are provided in Section III of the Sealed Quotation Documents.
- 3. Eligible suppliers may obtain further information and inspect the sealed Quotation documents at the office of Melamchi Municipality.
- 5. Sealed quotation documents may be purchased from the office of Melamchi Municipality, Melamchi by eligible bidders, on submission of a written application and upon payment of a non-refundable fee for sealed quotation documents as NRs 1000.00, until **2076/10/01** office hour from the first date of publication of this notice.
- 6. Sealed Quotations must be submitted at the office of the Municipal Executive, Melamchi, Sindhupalchok before **12:00 noon** on **2076/10/02**. Documents received after this deadline shall not be accepted.
- 7. Sealed Quotations will be opened in the presence of Bidders' representatives who choose to attend at **Melamchi Municipality, Melamchi** on **1:00 hr on 2076/10/02**. Sealed quotation must be valid for a period of **45 days** after sealed quotation opening and must be accompanied by bid security, amounting to NRs.50,000.00 which shall be valid for 30 days beyond the sealed Quotation validity period or If bidder wishes to submit the Bid Security in the form of cash, bidder has to deposit cash in deposit account No.1680300000004003001 of Melamchi Municipality at Nepal Bank Ltd., Melamchi Branch, and submit bank deposit voucher along with the sealed quotation.
